#### Introduction:-

The Shyam University has constituted the Anti Ragging Committee in the year 2024-25. The following instructions are framed to prevent the menace of ragging and foster healthy interpersonal relations among students in the campus of Shyam University, Dausa. Ragging is strictly forbidden in or outside the University campus. All students shall familiarize themselves with rules/regulations/guidelines on code of conduct, anti-ragging measures and discipline University. All 'new comers' should attend counseling sessions organized for them from time to time by the University staff.

## **Objectives:-**

- 1. To aware the students of dehumanizing effect to flagging inherent in its perversity.
- 2. To keep a continuous watch and vigil over ragging so as to preventers occurrence and recurrence.
- 3. To promptly and stringently deal with the incident so flagging brought to our notice.
- 4. Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers

#### **Functions of Committee:-**

- 1. To consider the complaints received from the students and conduct enquiry and submit report to the Anti- Ragging Committee along with punishment recommended for the offenders;
- 2. Over see the procedure of obtaining undertaking from the students in accordance with the provisions;
- 3. Conduct workshops again straggling menace and orient the students;
- 4. To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls;
- 5. To create awareness among the students about Anti ragging.
- 6. To take all necessary measures or prevention of Ragging inside the Campus/Hostels.
